OLD BUSINESS

a. INFORMATION/DISCUSSION: Board members were update on the pond issue by the representatives from Castle & Cooke and CCWD (Calaveras County Water District). After quite a bit of discussion it was determined that Duck Weed and Algae seems to be the primary cause of the odor coming from the ponds. They have received approval to put irrigation to create movement in the pond on #9. Mr. Haley also said that they might have to dredge the ponds. It was generally felt that as years have gone by it has got worse, and that might be also be part of the problem.

Mrs. Lopez (CCWD) said that stagnant water will have an odor and they feel that the steps that Castle & Cooke are currently taking are the correct ones to help elevate the problem. They will continue to work with Castle and Cooke to solve the problem. Ponds have been routinely tested and found to meet water quality standards.

Director Russ wanted to know "What was the cause of death for the fish on #8?" Mr. Fontz (CCWD) stated that sometimes this will happen due to turnover in the oxygen level. It just happens sometimes, and is normal.

PUBLIC COMMENT:

Phyllis Richard directed a question to Mr. Dave Haley. She is concerned about the rumors that Saddle Creek Golf Resort is up for sale. Mr. Haley advised that Saddle Creek it is not up for sale but they are always looking

for

investors to generate additional capital.
